## THE TOBACCO INDUSTRY ALL OVER AGAIN

Having struggled through the dismantling of the smoking culture, New Zealanders are now waking up to the serious damage being caused by alcohol. The economic cost alone is in the billions.

- 25% of New Zealand drinkers are heavy drinkers
- A third of all police apprehensions involve alcohol
- Half of serious violent crimes relate to alcohol
- Up to 75% of adult presentations at Emergency Departments on Thursday to Saturday nights are alcohol-related
- Over 500 serious and fatal injury traffic crashes every year
- At least 600 children born each year with FASD
- Over 1000 alcohol deaths every year
- More than 17,000 years of life per year lost through alcohol
- 70,000 alcohol-related physical and sexual assaults each year

As pressure mounts to better control the commercial forces driving the crisis, the alcohol industry is fighting back with the same tactics we saw with the tobacco industry:

- *Claiming it is simply a matter of individual responsibility and calling for better education*
- *Continually saying that only a small minority have a drinking problem*
- *Spending millions on advertising and political lobbying*
- *Denying the facts and calling for “more research”*

New Zealanders are under subtle but very clever attack. Many still believe the alcohol industry’s brainwashing, that:

- *Life can’t be enjoyed without alcohol*
- *Social events aren’t proper events without alcohol*
- *To be in the in-crowd means getting wasted with the in-crowd*

## 2010: A BIG YEAR FOR NZ

This year is a once in a generation opportunity to rein in what the Law Commission calls the “unbridled commercialisation of alcohol.”

If we don’t get active in large numbers the recommendations of the Law Commission and the World Health Organisation will be seriously undermined by alcohol industry lobbying and obfuscation.

## THE 5+ SOLUTION

Education and just hoping individuals will begin to act with more self-responsibility isn’t enough without effective regulation of the commercial forces pushing alcohol in our society.

The 5+ Solution is an evidence-based set of policy directives which will make a huge difference to the national alcohol crisis:

1. **Raise alcohol prices \***
  2. **Raise the purchase age**
  3. **Reduce alcohol accessibility**
  4. **Reduce marketing and advertising \***
  5. **Increase drink-driving counter-measures \***
- PLUS: Increase treatment opportunities for heavy drinkers.**

These are based on the internationally acclaimed, World Health Organisation publication “Alcohol: No Ordinary Commodity” written by fifteen of the top alcohol and public health scientists in the world. They have been further endorsed by a paper in the leading medical journal The Lancet.

The NZ Law Commission’s final report “Alcohol in our Lives – Curbing the Harm” closely follows the 5+ Solution.

Four hundred and fifty of the leading Doctors and Nurses in New Zealand has made a public stand endorsing the 5+ Solution.
